A system built for a business that cannot text: email and voice in under 60 seconds, a dispute-cycle engine that keeps clients past month five, and a partner program with monthly statements that never carry a score.

Enrollment Packet Flow

The CROA contract, the state information statement and the separate notice of cancellation go out on Sold, chased at 1 hour, 24 hours and 72 hours.

Document Chase with Live Checklist

ID, proof of address, SSN card or utility bill, and the monitoring login (IdentityIQ, SmartCredit) each get an upload link and reminders; staff see who is stuck at which document.

Dispute Software Sync

DisputeFox, Credit Repair Cloud or Client Dispute Manager pushes client status, stage, round number, items removed and remaining, and scores into hidden CRM fields via Zapier or API. Scores never leave the CRM.

Round-Went-Out and Results Emails

Branded, compliant emails triggered by the round date and by result changes, with a late-round alert to staff when a round is overdue. Silence between rounds is the second controllable cause of churn.

30/60/90-Day and Monthly Progress Reports

A per-bureau previous-to-new table with honest declines shown, one conditional recommendation, a predictable subject line, the owner always copied. No score in the message body; a log-in-to-your-portal link instead.

A NEW LEAD'S FIRST HOUR, AFTER THE BUILD

0:00	Lead submits a form, landing page or QR card — lands in the pipeline, tagged by source
0:01	Instant email goes out and an automatic call-back is placed — carriers forbid SMS in this category
0:01	Round-robin assigns the next person and notifies them
0:15	Nobody called? Reminder fires, and the owner sees it Monday
Day 1–5	No reply? A short follow-up drip runs, then stops
Sold	Onboarding kicks off on its own, and The Dispute-Cycle Engine takes over
